Special thanks was provided to John who had put a lot of time and effort into producing a much more improved version of a 'Vision, Objectives and Issues' resource that we had all been working on recently. This was now a much more thorough document and through email discussion it had been agreed that we need to lose the 'Issues' section of the document and replace this with a more formal 'Policies' section, as inline with national NP guidelines. Review of previous meeting	 All actions from the last meeting were discussed: ACTION: All to meet up to produce a final version of the draft 'Vision, Objectives and Issues' document recently commenced. Review of the Vision and Objectives resource	The main focus of today's meeting was to review the Vision, Objectives and Policies resource that John had compiled recently. All members of the group reviewed the document in detail together, making comments and generating discussion points where necessary.

	This was to ensure that the final version was purposeful and relevant to the needs of the residents of the Plan area. The accompanying 'Policies' document was also reviewed to ensure it met the requirements of the objectives themselves and to minimise any duplication across the 2 main sections. ENP Funding	Steve updated the group that the funding application for the next phase of the ENP project had been successfully approved and payment had been received into the Parish account. This will be required for all the work to be carried out by CCA over the forthcoming months in order to produce a draft Plan.
Cheshire Community Action (CCA)	Tamsin updated the group that Lucy at CCA was now in communication and awaiting our further resources to then commence in earnest our draft version of the eventual Plan. It was agreed that it would be wise to invite Lucy to the village so that she could gain a first-hand appreciation of the area and its key characteristics.

Housing needs data	John updated the group that there had been a recent release of the Eaton Housing Needs Advice Report published by Cheshire East. Again this contained totals that we a little contradictory to John's calculations and concerns were expressed that this total needs to be verified before we use formally within any of our Plan publications. ACTION: John to contact Tom Evans at Cheshire East for final clarification of actual housing needs totals
