





What is a Neighbourhood Plan?

- The result of a process introduced by the Government to provide local people an opportunity to have a say in the planning of their communities.
- It is led by the Parish Council who appoint a team of volunteers to consult with the residents and draw up a Draft Plan.
- It must align with the Local Authority Plan, in our case from Cheshire East.

Key messages in the Plan

Vision: Eaton is a small, historic and socially thriving community that will retain its quiet, rural identity whilst supporting its local economy and benefiting from a 21st Century infrastructure.

Objectives:

- To maintain a Green Gap between Eaton and Congleton to prevent coalescence
- Maintain the Local Character and Design of the village properties and the heritage of the village
- To ensure Moss Lane remains the settlement boundary for Congleton
- To protect the Green spaces and views plus key trees, hedgerows, lake, rivers and ponds
- To improve the communication infrastructure
- To support rural economy
- To allow a small number of appropriate infill houses up to 2030 only if required
- To ensure that the Quarry restitution when worked out involves the residents.

The next steps...

- Communicate the Draft Plan and supporting forms to residents and relevant stakeholders
- Obtain formal feedback by 11th November 2019
- Review feedback and decide if any significant changes are required
- Submit the Plan to Cheshire East for review by an independent inspector who may ask for changes
- Cheshire East then carry out a formal Referendum with the residents, ideally in Spring 2020
- **...PLEASE DO REMEMBER TO VOTE IN THE FORMAL REFERENDUM NEXT YEAR...IT IS YOUR VILLAGE AND YOU ARE FULLY ENTITLED TO HAVE YOUR SAY**
- If more than 50% of the residents approve the Plan it is then classed as 'accepted' by Cheshire East
- This final Plan can then influence any planning applications up to the end of the current planning period – 2030.
